## Eligibility

As per MHRD OM F.No. 33-4/2014-TS-III dated 24<sup>th</sup> June 2016 the fee waiver for socially and economically backward class students is as follows:

- ❖ The SC/ST/PH students shall get complete fee waiver
- ❖ The most economically backward students (whose family income is less than 1.00 lakh per annum) shall get full exemption/remission of the fee.
- ❖ The other economically backward students (whose family income is between 1.00 lakh to 5.00 lakh per annum) shall get 2/3<sup>rd</sup> exemption/remission of the fee.
