### Minutes of the Meeting cum Approval

The meeting scheduled for 24/06/2023 at 4 PM in the N1 classroom aims to address the incidents of indiscipline at the Hostels.

During the meeting, the committee outlined specific acts of indiscipline and their corresponding disciplinary actions. These are detailed in Table 1 (Category-I) and Table 2 (Category-II). Students found engaging in any acts mentioned in Table 1 (Category-I) will face the consequence of being barred from participating in any sports, clubs, or council activities. Additionally, their memberships in all related committees will be revoked.

- Non-availability of parents in the meeting if parents are called for meeting will lead to Withdrawal of T&P facility.
- The information about any of the above activities/actions will be given to the parents, by the faculty advisor and concern head of department.
- In case of hostel rustication, the remaining hostel fees and deposits will be forfeited.
- In case of any other indiscipline activity, the decision/recommendation of the Disciplinary Committee (DC) shall be final.
- Disciplinary Committee / Hostel committee is authorized to modify the quantum of action based on
- Any action taken as above will be informed to the Academic Section and Training &Placement Section based on severity.
- Fine will be imposed by Hostel Warden / Faculty / Chief Warden / DSW.
- Any misbehavior with girl student or harassment will be dealt by Internal Committee (IC)
- The student can put forward a request to Dean (SW) to set a "Jury of Appeal" through Faculty Advisor/Block Warden/Chief Warden, for possible consideration.
