C.1.1 Approval of Annual Report for the financial year 2016-17.

C.1.2 Grant of TA/DA to B.Tech/ M.Tech/ Ph.D students of NIT Goa

As per the resolution passed in 18th BoG meeting for grant of TA/DA to B.Tech/M.Tech/Ph.D students of NIT Goa, the expenditure should be incurred from Student Activity Fund of the Institute.

The annual Student Activity Fund collected by the Institute is approximately Rs.6.6 Lakhs. Apart from the grant towards TA/DA to B.Tech/ M.Tech/ Ph.D students, the expenditure on cultural activity, sports activity is also meet from the same head. The annual average expenditure on cultural and sports activity itself is Rs.4.2 Lakhs.

Hence, it is proposed that the TA/DA to M.Tech/ Ph.D students of NIT Goa for attending conferences/ seminars/ presenting papers, as a contingency grant, may be sanctioned from institute fund.

Board may approve of the same.

FC Resolution: Resolution: NIT Goa being a young institution, the accumulated IRG/Consultancy/testing earnings are minimal. It is very difficult to reimburse the expenses incurred by the student activities viz, cultural fest, technical fest, sports along with co-curricular and extra-curricular activities. Hence, FC recommends that the expenses incurred in terms of TA/DA of UG/PG students to attend the

conferences may be debited to institute fund. The total expenditure in this debit head will be approximately 3 lacs per annum on actual basis.

As per the resolution passed in the 18th BoG, supplementary agenda D.1, the Ph.D. contingency grant is debited from Institute fund.

C.1.3 Reimbursement of Telephone/mobile phone/broadband /data card use charges for eligible officials & regular Non-Teaching Staff.

As NIT Goa has eligible officials and non-teaching staff who are involved in multiple works which involve telecommunication within and outside the Institute as per the job requirement. At present eligible officials & non-teaching staff do not have telephone allowance. Other peer Institutes like NIT Warangal, NIT Surathkal and NIT Calicut (Copy of Board Resolution Enclosed) [page 10-11] extends this benefit to both eligible officials and non-teaching employees. It is proposed to reimburse monthly telephone Charges to them for performing official duty on the basis of Grade pay as per the following:

C.1.5 Financial Approval for the Construction of Compound wall through state PWD as Per GFR Norms.

Estimate is Rs. 9,95,27,890.00 from PWD and the same is tabled.

FC Resolution: FC opined that compound wall covering the new campus is a must and taken up on priority to avoid illegal encroachment and safeguard the land and materials during construction process. FC apprised with detailed estimate and drawing for this compound wall by the state PWD as per the GFR. FC approves and recommend the total estimate of Rs. 9,95,27,890.00 submitted by state PWD on deposit base.

Resolution: Time line of project may be for 6 month instead of one year and work may be awarded to two different agencies for the speedy completion of work.

C.1.6 Implementation of 7th CPC scale for teaching and non-teaching and clarification regarding payment of arrears

The 7th CPC scale for teaching and non-teaching staff is implemented from Jan 2018 as per the norms and 21st BoG resolution. However, the clarification regarding the payment of arrears is awaited.

FC Resolution: FC noted the letter of sanction of the arrears to be paid to the faculty and non teaching of NIT Goa vide MHRD letter F.No. 36-2/2017-TS.III dated 27th Feb 2018 also noted that respective fund of 385 lacs has been received. The total expenditure involved in paying the arrears to the all employee of NIT Goa is 87 lacs net (1.31 crore gross). Hence FC recommend to pay the arrears to all the employee as per the 7th pay commission.

C.1.7 Enhancement of Director Basic scale Rs 75000-79000 as per 6th CPC pay band Structure
