- C.1.1 Finalization of annual accounts of NIT Goa for the F.Y 2015-16

C.1.2 Distribution of Overhead Charges for testing/consultancy/ Research Projects:

In case of consultancy and testing activities, the share of the income from such works is divided as Institute Share and Departmental Share. Department share is distributed among the associated faculty and staff.

The distributions of testing/ consultancy charges are as follows:

The Department Share is distributed in the following ratio:

In the case of sponsored R&D projects, the project overhead charges may be distributed as follows:

- (i) Institutional Development Fund (IDF)- for common institutional developmental activities- 60%,
- (ii) Department Development Fund (DDF)- maintenance and repair of equipment and other activities of the Department concerned- 20%, and
- (iii) Personal Contingency Fund (PCF) for activities connected with professional development of the Principal Investigator of the project and members of the team (as decided by the Principal investigator), including participation in conference, travel, purchase of computer, printer, scanner, stationery etc.- 20% PCF can be used in combination with PDA.

Board approved the recommendation of the FC.

C.1.3 Financial incentives to faculty members for publication of papers:

It is proposed to give financial incentives to the faculty members for publication of papers from the fund generated by the Institute from its IRG. The financial incentives will be Rs.5000/- per paper on the basis of the impact factor. The impact factor will be decided by the Director NIT Goa in consultation with the experts in the respective field.
