Board took note of the actions taken on decisions of the last meeting. Director, NIT Goa informed the Board that the annual accounts for the financial year 2015-16 was audited by C&AG between 06/07/2016 and 22/07/2016 and the final audit report by C&AG is awaited. He proposed that that the final audit report for the financial year 2015-16 might get approved by the Members of the BoG through circulation. BoG accepted the proposal.

Reporting of Pay Enhancement of Medical Officer & Security In-Charge appointed on C.4 Contract

Institute has advertised for the post of Medical Officer on Contract vides advertisement no.NITGOA/NT/2016/715 dated 15/02/2014 and conducted Interview on 02nd April 2016, however the selected candidate did not join. Looking into the immediate requirement of a medical officer for the students and employees of the Institute a part time Medical officer on contract has been appointed on consolidated pay of Rs.35000/-. On the request of the Medical Officer, her pay was revised to Rs.40000/- on condition of increase of working hours.

Institute has appointed Mr. Raghu as Security-In-charge on contract to look after the proper management of security at Institute and hostels. An additional charge for sanitation has also been given to Mr. B.V Raghu. On his request his remuneration was revised from Rs.15000/- to Rs.20000/-
