#### Preamble:

The Director, NIT Goa welcomed the members of FC Meeting.

FC - Item No.1: Details of the grants received and Expenditure incurred are placed

before the members for information and approval.

FC took a note of it and approved. (appendix – I)

FC - Item No.2: Ratification of the approval of chairman, BOG, for consolidated

salary being paid to the teachers on contract basis.

The matter is placed before F C for consideration.

The structure of salaries for faculties on contract basis is approved and

is as follows:

Contract faculty with M.Tech qualification: 35,000/-

Contract faculty with Ph.D qualification: 42,000/- (appendix – II)

FC - Item No.3: Advt. given for faculty and non-faculty as per Sarangi Committee

Report and draft notification in circulation by MHRD.

The matter is placed before FC for consideration and approval.

Advt. for Faculty and Non-faculty are approved (appendix – III)

FC - Item No.4: Request for purchase of vehicle for the Institute.

The matter is placed before FC for consideration.

It is decided to hire/ lease the required vehicles for the Institute and for

the Director.

FC - Item No.5: The FC may recommend to MHRD for Four Tiers structure like in

IITs' with same terms and conditions.

The FC may consider and approve.

It is decided to recommend to MHRD to have the flexible cadre

structure similar to that of IIT for faculty.

FC - Item No.6: As Goa does not have air connectivity to important cities like

Delhi, Hyderabad etc. by Air India/ Indian Air lines, permission may be granted to Director and other officials to travel by other air lines other than Air India/ Indian Air lines, so as to save money and time. However, all efforts are to be made to travel by Indian

Air lines as far as possible subject to availability.

FC - Item No.7:

Approval for the sitting fee of Rs. 5000/- per session for FC/BOG meetings and other experts visiting the institute.

experts visiting the Institute.

FC - Item No.8:

Approval for the repairs to abandoned ITI hostel building as per the Expenditure estimates by CPWD. (appendix – IV)

CPWD estimates are approved and decided to assign the work to CPWD once the building is handed over to NIT Goa.

FC - Item No.9:

Request for Teaching and Non-teaching positions like in IIT (Faculty in new IIT is 1st year 30, 2nd year 60, 3 rd year 90)

FC - Item No. 10:

NIT Goa does not have proper accommodation for staff and students. Permission is sought for the rental buildings for staff and students for accommodation.

Approved and the rentals may be at the market rates.

FC - Item No.11:

NIT Goa does not have accommodation for director. Permission is sought to take the suitable building for Director's residence and Guest house for visitors on rental basis.

Approved and the rentals may be at the market rates.

FC - Item No.12:

Seeking permission to construct requisite buildings (Academic, residential, hostels) with pre-fabricated structures, once the land is allotted by State Government. The work is to be under taken as per GOI / CPWD norms.

This may be considered after the allotment of land to NIT Goa.

FC-Item No.13: Once space is made available, class rooms/labs are to be established, permission to incur expenditure for the purpose is sought.
