1. History of the Institute:

The National Institute of Technology Goa (NIT Goa) is a premier national-level technical institute in India established in 2010 by an act of parliament (NIT Act, 2007 and NIT (Amendment) Act, 2012). NIT Goa is an autonomous institute functioning under the aegis of Ministry of Education (MoE), Government of India, and has been declared an “Institute of National Importance”. The temporary campus is located in the hilly terrain of Farmagudi, Ponda, approximately 29 km southeast of Panaji, the capital of Goa. The permanent campus of NIT Goa, Cuncolim, South Goa, will be completed soon. Goa is well connected by roadways, railways and airways with various parts of the country. The Institute is dedicated to its academic excellence and aims to produce quality Engineers and Scientists.

The Institute offers undergraduate programmes in Five Engineering Departments: (1) Computer Science and Engineering (CSE), (2) Electronics and Communication Engineering (ECE), (3) Electrical and Electronics Engineering (EEE), (4) Civil Engineering (CVE), and (5) Mechanical Engineering (MCE). The Institute offers M.Tech. Programmes in the Three disciplines: (1) Computer Science and Engineering (CSE), (2) VLSI and (3) Power Electronics and Power Systems (PEPS). The Institute also offers Ph.D. degree in various stream of Engineering, Applied Sciences, Technology and Humanities & Social Sciences

The Institute admits students into the B.Tech. degree programme based on the ranks obtained in the Joint Entrance Examination JEE (Main) and the scheme of Direct Admission to Students Abroad (DASA). Intake of B.Tech. in Computer Science and Engineering/Electrical and Electronics Engineering/Electronics and Communication Engineering is 44 each, out of which 38 is through JoSAA/CSAB and 06 through DASA; and the Intake of B.Tech. in Civil Engineering/Mechanical Engineering is 42 each, out of which 37 is through JoSAA/CSAB and 05 through DASA. Therefore, total 216 students are pursuing B.Tech. at NIT Goa out of which 188 students have been admitted through JoSAA / CSAB and 28 through DASA. The Institute admits M.Tech. students through valid GATE score followed by CCMT (Centralized Counselling for M.Tech. Admissions), and few seats are offered to the sponsored and DRDO candidates. Intake of M.Tech. CSE/VLSI is 27 (23 through CCMT, 02 sponsored & 02 DRDO sponsored) each, and the intake of M.Tech. PEPS is 26 (22 through CCMT, 02 sponsored & 02 DRDO sponsored). The overall intake of M.Tech. is 80. NIT Goa also offers Full-time Self-Financed (Non-GATE) M.Tech. in those seats which remain vacant after admission through CCMT, sponsored, and DRDO categories is completed.

Presently there are six boys' hostels and one girls' hostel. Each hostel provides basic furniture, Wi-

Fi/LAN-enabled internet and Mess facilities. The Institute offers a bus service, connecting the temporary campus to the 'Kadamba Bus Stand' in Ponda, Goa. The Institute is well-equipped with laboratories, workshops and has an up-to-date Library with rich and comprehensively high-quality print and electronic resources. The Training and Placement Cell of NIT Goa aims to provide opportunities to students to shape their career. Major companies keep visiting the transit campus of the institute regularly. They are from varied sectors: Research and Development, Engineering & Technology, IT/Software Development, Analytics, Finance, Education, Consulting, Public Sector Undertaking and others. Some notable companies are : Navratna Public Sector Undertaking (PSU) like Bharat Electronics Limited, Indian Space Research Organisation (ISRO), Multinational Corporations including Amazon, Samsung, Oracle, Dell, Intel, Qualcomm, Global Foundries, IBM, Capgemini, Jio, AMD, Bosch, ZS Associates, Tata Power, L&T, HDFC, Jindal South West, HCL Technologies, Adani Group, Infosys, TCS, Cognizant, Inceff, Schneider Electric, Aequus, Publicis Sapient, Accenture, ASEC Inc., Persistent Systems etc. Additionally, the institute has witnessed an increase in the number of internships offered to pre-final year students by MNCs like Samsung, Dell, Intel, etc. NIT Goa signed many MoUs and Agreements with other academic & research institutes, industries and organizations to facilitate faculty and student exchange programs, knowledge sharing, carrying-out interdisciplinary research works, joint research guidance, curriculum and course developments, joint workshop, conferences, seminars, and many more student and faculty development programs.

All the faculty members of NIT Goa are dedicated to training the students with a world-class education. Faculty members are actively involved in research works and have executed many funded R & D projects. They have been publishing research articles and book chapters regularly. Many faculty members have been granted and many have filed patent/patents. Institute has organised several GIAN, STTP, FDP, Workshops, National and International Conferences etc. The Institute also organises outreach activities/initiatives like 'Rashtriya Aavishkar Abhiyan (RAA)', 'Unnat Bharat Abhiyan', 'Swachh Bharat Abhiyan', 'Ek Bharat Shreshtha Bharat', 'FiT India' programmes, and many more.

The students of NIT Goa are actively involved in various co-curricular activities through students' clubs, councils, and study circles like SPECTRA, TESLA, QUANTA, CESCO & META etc. The SPIE and IEEE student chapters of the Institute organise various scientific and research-oriented events. The annual technological fest of NIT Goa is SAAVYAS. For overall development of the students, the institute also provides sports facilities. In 2018, NIT Goa organised All India Inter NIT Faculty and Staff Tournament. The students also celebrate cultural festivals of different states of India to maintain unity in diversity and it is a collective effort by the institute to inculcate integral education of mind and body.

The institute was functioning in the premises of Goa Engineering College till December 2012. The campus was shifted to the renovated building of Industrial Training Institute (ITI) in the same premises. The renovation of the building was carried out by NIT Goa. The new buildings accommodate thirteen class rooms, eight laboratories, one conference room, and one seminar hall with seating capacity of 120 persons, a workshop and an administrative office.

In the F.Y 2015-16 Institute also has its own medical centre and canteen facility in the temporary premises.

On July 2017 state Govt. handed-over the land measuring 120 Acres identified for the permanent campus of NIT Goa at Cuncolim Goa.

The campus is in near completion stage and we will be moving shortly in a few months time.

2. Academic History

National Institute of Technology Goa (NIT Goa) is a premier technical Institute of the region. NIT Goa was established in the year 2010 by an act of parliament (NIT act 2007) and it is declared as '**Institute of National Importance**'. NIT Goa is an autonomous institute and functioning under the aegis of Ministry of Human Resource Development (MHRD), Govt. of India. NIT GOA is one of the ten newly set up NITs during the 11th Five Year Plan by the Ministry of Human Resources Development (MHRD). The institute was to be set up using Rs. 250 crore provided by central government. The first batch of students was admitted in 2010 and academic activities of NIT Goa started in the academic year 2010-11.

NIT Goa started functioning in 2010 with three Engineering Departments: (1) Computer Science and Engineering (2) Electronics and Communication Engineering and (3) Electrical and Electronics Engineering at undergraduate level. NIT Goa attracts students from all over the country and abroad. The Institute admits students to B. Tech Degree program on the basis of ranks obtained in the Joint Entrance Examination (JEE main) with an intake of 30 students in each branch and the scheme of Direct Admission of Students Abroad (DASA). Forty percent of the seats are reserved for the students of Goa, Ten percent Diu Daman, Dadra Nagar Haveli & Lakshadweep and the remaining seats are based on the all India rank. The institute also admits students to M.Tech and Ph.D. Degree Programs. The institute is sincerely attempting to deliver quality education and to achieve excellence in teaching, learning and research with high professional ethics.

Structure of B.Tech. Programme

The medium of instruction, examination and project reports are in English.

Undergraduate B.Tech Degree programmes are offered by the departments (i) to (v) and all the below listed departments offer courses in the B.Tech Programme.

- i) Computer Science and Engineering (CSE)
- ii) Electrical and Electronics Engineering (EEE)
- iii) Electronics and Communication Engineering (ECE)
- iv) Mechanical Engineering (MCE)
- v) Civil Engineering (CVE)
- vi) Department of Applied Sciences (APS), covering areas such as:
 - a. Mathematics (MA)
 - b. Physics (PH)
 - c. Chemistry (CY)
- vii) Department of Humanities and Social Sciences (HSS), covering areas such as:
 - a. Economics (HS)
 - b. English (HU)

In addition, the departments also offer courses under mandatory learning category, Indian knowledge systems and others.

The programme structure consists of the following:

- i) A general (common) core programme comprising of basic sciences, basic engineering sciences and technical arts, humanities and social sciences, Indian knowledge systems.
- ii) department core courses introducing the student to the foundations of engineering in the respective

branch;

- iii) department elective courses enabling the student to opt and undergo a set of courses of interest;
- iv) Open elective courses enabling the student to opt and undergo a set of courses of interest from other departments for nurturing interdisciplinary interest;
- v) Professional practice including project, Comprehensive Viva-Voce and industrial training/summer internship (for 6-8 weeks) and,
- vi) Courses on Environmental Studies, Physical Education, Professional Ethics and Human Values, Liberal Arts, Innovation & Entrepreneurship.

Every branch of the B.Tech. programme will have a curriculum and syllabi for the courses approved by the Senate. Every department has a prescribed course structure which in general terms is known as Curriculum or Course of Study. It prescribes courses to be studied in each semester. The courses of study bulletin are available in the Institute's website.

The Institute follows a credit-based semester system. There are two regular semesters in a year. The semester normally that begins in July/August (*July/August to December*) is known as 'ODD' semester and the semester that begins in January (*January to May*) is known as 'EVEN' semester.

The complete programme will consist of 9 classifications, as given in Table 1. namely- basic sciences, basic engineering sciences and technical arts, humanities and social sciences, Indian knowledge systems, department theory & practice, and Others, distributed over eight semesters with two semesters per academic year. Department Core courses will commence from the third semester. The elective courses will normally be offered from the sixth semester. However, the departmental board of studies will decide the final course structure.

The academic programmes of the Institute follow the credit system. The general pattern is: one credit for each lecture hour per week per semester; two credits for each laboratory/practical session of three hours per week per semester, one credit for each laboratory/practical session of two hours per week per semester and one credit for each laboratory/practical session of three hours per week per half semester. However, there can be a few special courses with a slight variation in credit allotment.

The curriculum of any branch of the B. Tech. programme shall have a total of minimum 168 credits. Every course of the B.Tech. programme will be placed in one of the classifications listed in Table.1. The minimum credits to be earned for the award of B.Tech. degree are 168.

The courses - Physical Education, Environmental Studies, Professional Ethics and Human Values are of Pass/Fail (i.e., non-credit) category which will not be included in the computation of SGPA/CGPA. They are graded either Satisfactory (SA) or Unsatisfactory (US). However, satisfactory completion of these courses is mandatory for degree completion.

Departmental courses (DC and DE) constitute atleast 60% of the total curriculum. Further, students are allowed open electives (OE) to broaden their inter-disciplinary knowledge base and to specialize in an area outside the parent discipline.

As part of implementation of National Education Policy (NEP-2020), the Institute has introduced Minors in various disciplines.

Structure of M.Tech Programme

- The medium of instruction, examination and project reports will be English.
- Postgraduate (M.Tech Degree) programmes are offered in the following disciplines by the respective programme hosting Departments.
 - i) Master of Technology in “Computer Science and Engineering” (M.Tech. (CSE)) by the Department of Computer Science and Engineering (CSE)
 - ii) Master of Technology in “VLSI” (M.Tech. (VLSI)) by the Department of Electronics and Communication Engineering (ECE).
 - iii) Master of Technology in “Power Electronics and Power Systems”(M. Tech. (PEPS))by the Department of Electrical and Electronics Engineering (EEE)Other teaching Department, Humanities and Sciences (HS) shall offer courses for these three different programmes.
- Each programme of instruction consists of the following:
 - i) An engineering “Programme Core” introducing the student to the state of the art in engineering in the respective branch.
 - ii) A “Programme Elective” enabling the student to opt and undergo a set of specialized courses;
 - iii) A “Professional practice” which includes independent study, seminar, comprehensive-viva, technical communication, etc.

iv) A Dissertation work on specialized advanced engineering and/or research work of state of art nature.

- Each of the postgraduate programmes will have a curriculum and syllabi for the courses approved by the Senate. Every department has a prescribed course structure which in general terms is known as “Curriculum” or “Courses of Study”. It prescribes courses to be studied in the programme in each of the semesters as well as credits earned. The courses of study bulletin are available in the Institute’s website.

- The Institute follows a credit based semester system. There are two regular semesters in a year. The semester that begins in July (July to December) is known as „ODD “Semester and the semester that begins in January (January to June) is known as „EVEN“ Semester. The general pattern is: One credit for each lecture hour per week per semester; Two credits for each laboratory course of three to four hours per week per semester.

- The complete programme will consist of 4 categories (as given in the Table 1): Core, Electives, Dissertation work and Professional Practices distributed over four semesters with two semesters per academic year.

- The curriculum of any branch of the M. Tech. programmes shall have a total of minimum 64 credits. Minimum credits or each of the categories are specified in the Table below, which has to be earned by students for the award of M.Tech. degree.

Every course of the M. Tech. programme will be placed in one of the 4 categories as listed in Table.

Procedure followed in Decision Making Process

The Institute has a Director, Six Deans, a Registrar and Heads of the Departments/section, who carry out the various functions of the Institute as per procedures laid down in the Statues of the Institute. The decision is communicated to public by notices, announcements, website and advertisements. The final authority to vet the final decision is the Director / Board of Governors / Council for NITs. The Institute takes decision regarding students' affairs, faculty & staff affairs, facilities of the Institute and its infrastructure.

3.8 Stages through which Proposal/Scheme is being implemented:

Officials/ Officers: As per the work allocation orders issued to Official/Officers from time to time, the proposals/files are examined and further submitted to the Director of the institute for administrative sanction/approval.

Director: Give the administrative/financial approvals and if required the file is further forwarded to MoE for their concurrence. After going through all these stages the scheme/proposal is implemented by the University.

3.9 Time limit for taking decisions varies from project/programme to project/programme. The routine Correspondence, etc. received from different departments are of time bound nature and disposed of within the given time limit by the institute.

6.1 Transfer Policy and Transfer Orders:

Transfer of Non-Teaching employees is done as per requirement and employee request. The NIT, Goa is a Central Autonomous Body under the Department of Higher Education, Ministry of Education, Govt. of India. There is no provision for transfer from one Autonomous Body to other Autonomous Body. As such, there is no transfer policy for Teachers of the Institute.

However, internal transfers of the employees of Institute have been made from time to time for internal management. The Competent Authority (CA) constitutes committees consisting of administrative & academic authorities, on whose recommendations and acceptance by the CA, the decision for handling of additional charge to employees are taken in addition to their existing duties. On transfer of a staff from one section to another, they have to handover the charge to another person and take charge of their respective section. In case of additional charge is assigned to an employee, they have to perform additional duties of additional charge assigned in addition to their existing duties.

The constitution of Committee:

16. FREQUENTLY ASKED QUESTIONS (FAQs) ON RTI

Q.1. What is Information?

Information is any material in any form. It includes records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form. It also includes information relating to any private body which can be accessed by the public authority under any law for the time being in force.

Q.2. What is a Public Authority?

A "public authority" is any authority or body or institution of self government established or constituted by or under the Constitution; or by any other law made by the Parliament or a State Legislature; or by notification issued or order made by the Central Government or a State Government. The bodies owned, controlled or substantially financed by the Central Government or a State Government and non-Government organisations substantially financed by the Central Government or a State Government also fall within the definition of public authority. The financing of the body or the NGO by the Government may be direct or indirect.

Q.3 What is a Public Information Officer?

Public authorities have designated some of its officers as Public Information Officer. They are responsible to give information to a person who seeks information under the RTI Act.

Q.4. What is the Fee for Seeking Information from Central Government Public Authorities?

A person who desires to seek some information from a Central Government Public Authority is required to send, along with the application, a demand draft or a banker's cheque or an Indian Postal Order of Rs.10/- (Rupees ten), payable to the Accounts Officer of the public authority as fee prescribed for seeking information. The payment of fee can also be made by way of cash to the Accounts Officer of the public authority or to the Assistant Public Information Officer against proper receipt. However, the RTI Fee and the mode of payment may vary as under Section 27 and Section 28, of the RTI Act, 2005 the appropriate Government and the competent authority, respectively, by notification in the Official

Gazette, make rules to carry out the provisions of this Act.

Q.5. What is the Fee for the BPL applicant for Seeking Information?

If the applicant belongs to below poverty line (BPL) category, he is not required to pay any fee. However, he should submit a proof in support of his claim to belong to the below poverty line.

Q.6. Is there any specific Format of Application?

There is no prescribed format of application for seeking information. The application can be made on plain paper. The application should, however, have the name and complete postal address of the applicant.

Q.7. Is it required to give any reason for seeking information?

The information seeker is not required to give reasons for seeking information.

Q.8. Is there any provision for exemption from Disclosure of Information?

Sub-section (1) of section 8 and section 9 of the Act enumerate the types of information which is exempt from disclosure. Sub-section (2) of section 8, however, provides that information exempted under sub-section 3 (1) or exempted under the Official Secrets Act, 1923 can be disclosed if public interest in disclosure overweighs the harm to the protected interest.

Q.9. Is there any assistance available to the Applicant for filing RTI application?

If a person is unable to make a request in writing, he may seek the help of the Public Information Officer to write his application and the Public Information Officer should render him reasonable assistance. Where a decision is taken to give access to a sensorily disabled person to any document, the Public Information Officer, shall provide such assistance to the person as may be appropriate for inspection.

Q.10. What is the Time Period for Supply of Information?

In normal course, information to an applicant shall be supplied within 30 days from the receipt of application by the public authority. If information sought concerns the life or liberty of a person, it shall be supplied within 48 hours. In case the application is sent through the Assistant Public Information Officer or it is sent to a wrong public authority, five days shall be added to the period of thirty days or 48 hours, as the case may be.

Q.11. Is there any provision of Appeal under the RTI Act?

If an applicant is not supplied information within the prescribed time of thirty days or 48 hours, as the case may be, or is not satisfied with the information furnished to him, he may prefer an appeal to the first appellate authority who is an officer senior in rank to the Public Information Officer. Such an appeal, should be filed within a period of thirty days from the date on which the limit of 30 days of supply of information is expired or from the date on which the information or decision of the Public Information Officer is received. The appellate authority of the public authority shall dispose of the appeal within a period of thirty days or in exceptional cases within 45 days of the receipt of the appeal.

Q.12. Is there any scope for second appeal under the RTI Act?

If the first appellate authority fails to pass an order on the appeal within the prescribed period or if the appellant is not satisfied with the order of the first appellate authority, he may prefer a second appeal with the Central Information Commission within ninety days from the date on which the decision should have been made by the first appellate authority or was actually received by the appellant.

Q.13. Whether Complaints can be made under this Act? If yes, under what conditions?

If any person is unable to submit a request to a Public Information Officer either by reason that such an officer has not been appointed by the concerned public authority; or the Public Information Officer has refused to accept his or her application or appeal for forwarding the same to the appellate authority, as

the case may be; or he has been refused access to any information requested by him under the RTI Act; or he has not been given a response to a request for information within the time limit specified in the Act; or he has been required to pay an amount of fee which he considers unreasonable; or he believes that he has been given incomplete, misleading or false information, he can make a complaint to the Information Commission.

Q.14. What is Third Party Information?

Third party in relation to the Act means a person other than the citizen who has made request for information. The definition of third party includes a public authority other than the public authority to whom the request has been made.

Q.15. What is the Method of Seeking Information?

A citizen who desires to obtain any information under the Act, should make an application to the Public Information Officer of the concerned public authority in writing in English or Hindi or in the official language of the area in which the application is made. The application should be precise and specific. He should make payment of application fee at the time of submitting the application as prescribed in the Fee Rules.

Q.16. Is there any organization(s) exempt from providing information under RTI Act?

Yes, certain intelligence and security organisations specified in the Second Schedule, are exempted from providing information excepting the information pertaining to the allegations of corruption and human rights violations. Courtesy – Guide on Right to Information Act, 2005 issued by the department of personnel and training Ministry of Personnel, Public Grievances and Pension Government of India.

Q. 17. Will I be informed about the additional fee (if any) is required to pay?

In case additional fee representing the cost is required for providing information, the CPIO will intimate the same, which can be viewed by the applicant through "View Status" option in the RTI Online Portal and an e-mail alert or SMS or both will also be sent to the applicant for the same. For payment of additional fee online, the applicant needs to use the option 'View Status' in the RTI Online Portal and on providing the registration number of the request, option for "Make Payment" will be available.

Q. 18. How do I file an appeal with First Appellate Authority?

For making an appeal to the first Appellate Authority, the applicant has to select the option "Submit First Appeal" in the RTI Online Portal and fill up the form that will appear. The registration number and e-mail ID of the original application is required for filing the first appeal.

Q. 19. Is it mandatory to create user account on RTI online web portal?

No. You can directly file your RTI on "Submit Request" tab.

Q. 20 What should I do if amount is deducted from my account but registration number is not generated?

Please do not attempt to make payment repeatedly or try to submit request once again. Kindly wait for the 24 to 48 working hours as registration number will be generated after reconciliation. If it is not generated within stipulated time frame then kindly send an e-mail at [help@rtionline-dopt\[at\]nic\[dot\]in](mailto:help@rtionline-dopt[at]nic[dot]in) with your transaction details.

Q. 21 What should I do when portal is not allowing me to file the first appeal?

This may happen under following two situation:
1) When your RTI application has been physically transferred to other public authority, which is not aligned to this portal. In such a case, you are required to file your appeal in physical mode to the concerned public authority.




2) Another case can be if your RTI application has not been replied to by CPIO and 30 days period has not lapsed. In such a case, you may file first appeal only after completion of stipulated time period of 30 days.

Q 22. How to upload a supporting document if an alert comes as "SUPPORTING DOCUMENTS REQUIRED FROM APPLICANT"?

When a Public Authority request for supporting document, an alert is sent to the applicant to his/her Mobile or Email Id. In such situation, the applicant is requested to visit the RTI Online Website and enter the details in 'View Status'. Once the detail is entered, the current status of the RTI application is shown along with the option for uploading the supporting document.

Q 23. Can I file RTI application for state public authorities through this portal?

No. This Portal is exclusively meant for Public Authorities under Central Govt. only.




