## Minutes of Fourth Meeting of BWC of NIT Goa held on June 09, 2018 in the Conference Room of NIT Goa

The fourth meeting of BWC was held under the chairmanship of Dr. Gopal Mugeraya and the following members were present.

The Chairman welcomed all the members and he then instructed the Registrar (I/C) to present the agenda items, as Member Secretary of the BWC.

The Registrar (I/C) presented the agenda items and the BWC made the following recommendations/ took the following decisions.

Item No. C.1.: Renovation of old ITI building to use as faculty block of NIT Goa at Farmagudi Ponda (including Internal and External Electrical Works) and Providing and fixing pavers around Faculty cabins for NIT Goa in ITI. campus with total estimated cost of Rs. 51,24,032/- submitted by PWD.

The BWC examined item-wise estimation for the above work made by State PWD as per approved scheduled rates of PWD, Goa and accepted the estimation for placing the same to FC and BoG to accord administrative approval and expenditure sanction. The BWC also accepted that the work should be given to PWD, Goa for execution on deposit work basis as per GFR 133(2).

Item No. C. 2: Repairs and painting to quarters E/D, E/E & E/F in GEC complex at Farmagudi (including Internal Electrical Works) with total estimated cost of Rs. 13,53,533/- submitted by PWD.

The BWC examined item-wise estimation for the above work made by PWD as per approved scheduled rates of PWD, Goa and accepted the estimation for awarding the work to PWD, Goa for execution on deposit work basis as per GFR 133(2).

Item No. C.3: Providing Galvulium sheet Roofing for Hostel D1 and D4 and repairs to existing roof of D3 and D6 of NIT Goa with total estimated cost of Rs 28,78,390/- submitted by PWD.

The BWC examined item wise estimation for the above work made by PWD as per approved scheduled rates of PWD, Goa and accepted the estimation for awarding the work to PWD, Goa for execution on deposit work basis as per GFR 133(2).

Item No. C. 4.1: Signing of MoU with PWD Goa for assigning whereas works on depository work basis, as and when required and as decided by the competent authorities of NIT Goa.

The BWC felt that whenever any work is given to PWD, Goa on depository work basis as per provision of GFR-140, NIT Goa may sign one MoU for each work which will include the terms and condition of payment, item-wise works to be executed with estimated rates, completion time of the work etc. which will be signed by the Registrar/Registrar(I/C) of NIT Goa and authorized officials/Engineer of PWD,Goa.

Item No. C. 4.1: To receive information regarding certain urgent works already awarded/completed based approval given by the Director, NIT Goa in his capacity as chairman of BWC.
