GENERAL INSTRUCTIONS FOR THE CANDIDATES

- 1. Applicant must address their representation to <u>recruitment@nitgoa.ac.in</u> within 15 days from the date of uploading of this notification on the website.
- 2. All the shortlisted candidates who are serving in Government/Semi-Government/Autonomous Bodies/Statutory Bodies /PSUs/PSBs should furnish a No Objection Certificate (NOC) from the designated authority of the organization at the time of written test/interview (as applicable), failing which their candidature will not be considered for further selection process. However, candidates serving in NIT Goa, need not to produce the NOC.
- 3. The representations are received after the due date, will not be entertained.
- 4. In case the candidates has applied for different posts they need to submit the representation separately for each post applied, consolidated representation will not be entertained.
- 5. Applicants must mention their name as per their application form, the post applied for and their application ID in the subject line. Rest matter may be mentioned in the body of the mail.
- 6. The candidates who are provisionally shortlisted due to partial fee payment for some technical reason are hereby provided with an opportunity for submission of the remaining fee with in the stipulated time frame, in case the candidate fails to submit the fee or supporting document within the prescribed time the candidature will be rejected and the application fee will be forfeited.
